Adoption Services: The Lawrence Humane Society accepts and cares for animals relinquished by owners and other individuals, stray animals found within the City of Lawrence and Douglas County, as well as other animal welfare agencies agencies. In 2015, LHS took in 2937 live animals and had an 89% live release rate. There is no limit on how long an animal may stay and 100% of friendly, healthy, and treatable animals are cared for until a positive outcome is achieved.

4b (Code: _____) (Expenses \$ 196,043 including grants of \$ _____) (Revenue \$ _____)
Medical Care: Dogs and cats available for adoption are provided with vaccines, de-worming, flea treatment, spay/neuter surgery, as well as other medical treatment and testing needed. The Lawrence Humane Society has a veterinarian on staff that treats animals according to their medical needs prior to adoption. The staff veterinarian is afforded discretion to engage in special projects to assist animals with exceptional medical needs.

Volunteers: LHS volunteers assist in virtually every aspect of the organization from providing daily enrichment to providing superior client care. In 2015, LHS had more than 400 active volunteers. There were more than 50 volunteers who were available to foster animals in their homes. More than 600 animals were fostered temporarily outside of the shelter by volunteers during 2015. LHS provides all food, veterinary care, and supplies for foster pets.
