**Placement Services: The Lawrence Humane Society accepts and cares for animals relinquished by owners and other individuals, stray animals found within the City of Lawrence and Douglas County, as well as other animal welfare agencies lacking time, space, or resources to find positive placement for their animals. In 2017, LHS took in 4,331 animals, and had 92% live release rate through pet adoption programs, lost pet reunion efforts, and strategic transfer initiatives. There is no limit on how long an animal may stay in the shelter's care and 100% of friendly, healthy, treatable, and rehabilitatable animals are cared for until a positive outcome is achieved.**

**Medical Care: The Lawrence Humane Society employs two full-time veterinarians to treat animals according to their medical needs prior to adoption. Dogs and cats available for adoption are spayed or neutered and provided with vaccines, de-worming, flea treatment, and other medical treatment and testing needed. In addition, our veterinary staff is afforded discretion to engage in special projects to help animals with exceptional medical needs.**

**Volunteers: Lawrence Humane Society volunteers assist in virtually every aspect of the organization -- from providing daily enrichment to pets to providing superior customer service and assistance to guests. In 2017, 1068 volunteers provided more than 15,500 hours of service -- the equivalent of seven full-time and one part-time staff. In addition, more than 200 volunteers participated in our foster program, providing temporary care to animals in need within their homes. More than 675 animals were fostered temporarily by these volunteers, with LHS providing all food, veterinary care, and supplies for foster pets.**
